## Voting conditions

1. A Member may use the proxy voting form or online voting service to appoint a proxy to vote on your behalf. You may appoint the Chair of the Meeting as your proxy. Your proxy may vote for you at the AGM but only on a poll. A poll is a formal vote which may take place after an initial vote by a show of hands.
2. You may instruct your proxy how to vote at the meeting. Please read the instructions on the voting form.
3. The last date for receipt of proxy votes is 21 April 2025.
4. You are entitled to vote if:
  - a. you are aged 18 years or over on 23 April 2025 **AND**
  - b. you i. had a shareholding in the Society of at least £100 on 31 December 2024 **OR**
    - ii. owed at least £100 to the Society on a mortgage loan on 31 December 2024 **AND**
  - c. you i. have not ceased to hold shares in the Society at any time since 31 December 2024
    - ii. owe the Society not less than £100 on a mortgage loan on the voting date **AND**
  - d. you are the first named account holder in our records.
  - e. Only one vote will count irrespective of:
    - i. the number of accounts you hold and whether you hold accounts in different capacities (for example, on your own behalf and as a trustee) **OR**
    - ii. whether you qualify to vote as both a shareholding member and a borrowing member **OR**
    - iii. the amount of your shareholding or of your mortgage debt.
